*Please add one to five keywords to your article. Keywords are essential for the accessibility and retrievability of your article. Keywords assigned to articles will be assembled in a keyword index, which will be printed in the last issue of each volume for each journal, and in cumulative indexes. In addition, it is planned to make keywords available on Internet. To maximize the consistency with which such keywords are assigned by different authors, the following guidelines have been drawn up. Each keyword (which can be a phrase of more than one word) should describe one single concept. Words like "and" or "of" should be avoided. Avoid very general keywords which become meaningless once in a keyword list, e.g. "action", "computer", "mathematics". Check whether the keywords describe the outline of the article on the whole. Use natural language: for instance "automatic error recovery" rather than "error recovery, automatic". Try to use nouns and adjectives as much as possible (i.e. use "automatic error recovery" rather than "recovering errors automatically"). Do not use nouns in the plural form. Use English rather than American spelling (regardless of the spelling used for the article itself). Avoid the use of abbreviations as much as possible, unless an abbreviation is so well-established that the full term is rarely used (e.g. use "laser" instead of "Light Amplification by Stimulated Emission of Radiation", but use "computer aided design" instead of "CAD"). Although these guidelines are not mandatory, they should be adhered to where possible.*

## **Abstract**

The Abstract should be limited to about 150 words and should be self-contained (contain no footnotes). It should be adequate as an index (giving all subjects, major and minor, about which new information is given) and as a summary (giving the conclusions and all results of general interest in the article). It must appear on its own sheet separate from the text.

## 1. Introduction

Begin with an introduction, followed by experimental paragraphs, conclusions and acknowledgements, and finally references.

The Manuscript, including the abstract, references, and captions, should be neatly typed in English, double-spaced, on one side only of 21.6 x 28 cm (8-1/2 x 11 in. or A4) white paper with ample margins (such as this example page). Number all pages in single sequence beginning with the title and abstract page.

The manuscript is to be submitted in *non-typeset* form consisting of the text followed by figures and tables. Once typeset by the publisher, it should not exceed a length of six (6) journal pages in the special issue of MEE. Authors are cautioned that discovery of excess length might not occur until at a late stage of the publication process and would then result in delay and expense.

For an estimate of final length, see the guidelines given on the MNE 02 web page under the proceedings section and also see the example pages hereafter.

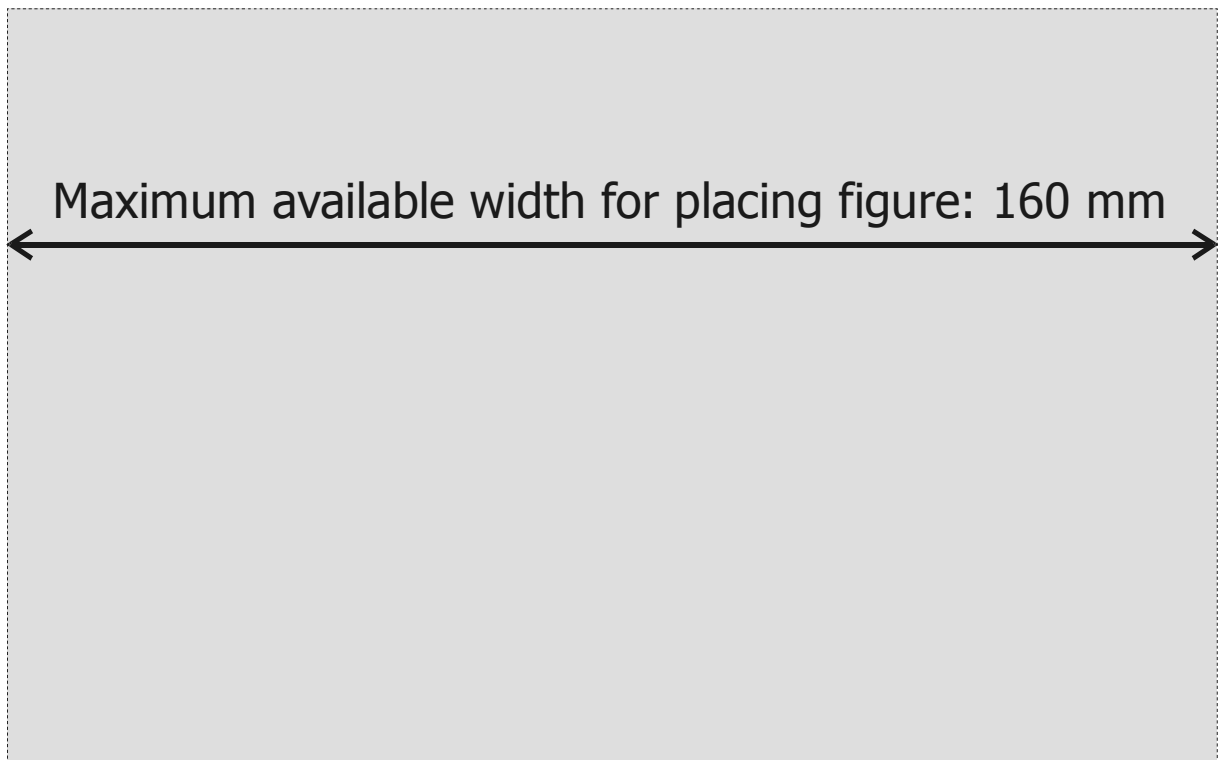

*Prepare and submit each illustration in the final size in which it will be published, not oversized or undersized. The maximum width is 16 cm. The figure height of course depends on its content.*

*Ensure a minimum of 8-point type size (2.8 mm high) and 1-point line width within illustrations. Ensure that line widths will be 0.5 points or greater in the final published size. Line widths below 0.5 points will reproduce poorly. Avoid inconsistencies in lettering within individual figures, and from one figure to the next. Lettering and symbols cannot be handwritten.*

*Number figures in the order in which they appear in the text. Label illustrations with their number, the name of the first author, on the front of the figure well outside the image area. Place only one figure per page (including all parts). Place all parts of the same figure on one sheet of white bond paper. Label all figure parts with (a), (b), etc.*

*Please be aware that a typical figure of 70 mm height including legend displaces about 270 words; each 1.0 mm of figure height will displace about 4 words of text. As author you have to take this into account when estimating the full manuscript length.*

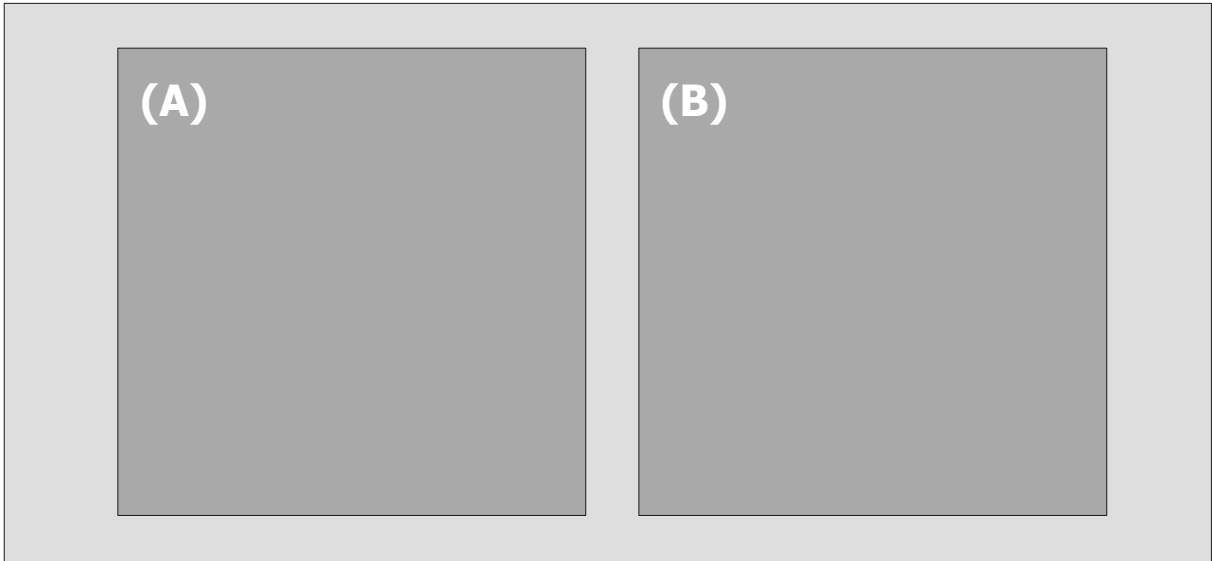

*This is another example for a possible figure page. As the text will be type set in single columns of about 16 cm width, it is up to the authors to group figures side-by-side, e.g. sub-figures a), b), c) etc., to make best use of the maximum width of 16 cm. When reducing the figure size, please ensure that the details and labels are still clearly readable.*
